George C. Mann served as the Chief of the Bureau of Adult Education and Executive Secretary for CCAE in the 1940s and 1950s. During his twenty-two-year career as an adult education leader, the concept of public-school adult education in California went from dream to reality. His affectionate nickname, "Mr. Adult Education," was inspired by his devotion and tireless work on behalf of public-school adult education. It is fitting that our highest honor bears his name.
